ORGANIZATIONAL PROFILE

Karunya Trust is a non-governmental organization, registered in 1998 under the Bombay Public Trust Act 1950 (Reg. No. E-18021) and Foreign Contribution (Regulation) Act. The Trust aims at providing a 'safety net to poor', particularly the disadvantaged children like those living on the street, rag-pickers, HIV/ AIDS-affected and children from underprivileged tribal background. It also helps the deprived and destitute women by rehabilitating and providing them with alternate means of livelihood. The core values of Karunya are: Sanctity of human life, rights and dignity; dignity of women and work; rights of workers and options for the poor; solidarity, respect to ecology and environment; civilization of love and a culture of peace, justice, freedom, and fellowship. The Trust is guided by its vision and mission based on the Gospel values under the guidance of the governing body.

Karunya Trust works with local people to mobilize, facilitate, and scale up sustainable community-driven responses to various societal issues. Its major focus areas are education, livelihood, health, environment issues, women empowerment and good governance which it accomplishes by building community-based organizations for capacity development and leadership training. It collaborates with like-minded organizations and government agencies to strengthen its network and build strong mutually beneficial support systems.

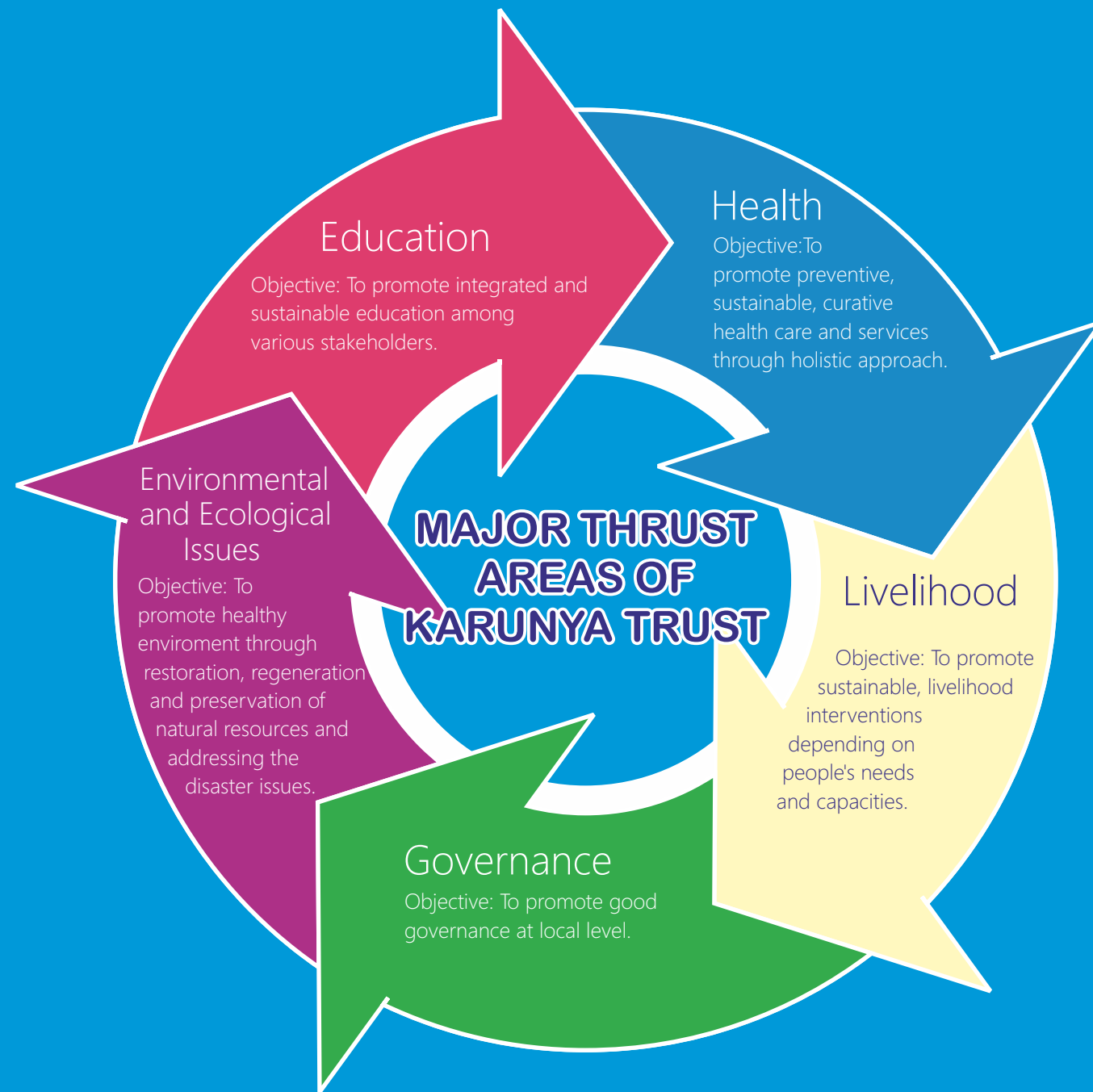

Project for the protection and promotion of the basic and environmental rights of Rag picking children in the dump yards of Govandi, Mumbai. It is set up at Rafik Nagar, an area with close proximity to the Dumping ground and notorious for Drug Addiction, Child Labour, Abuse, and Illiteracy.

The National Institute of Open Schooling (NIOS)

National Institute of Open School (NIOS) is the choice opted by most teenagers from Rafik Nagar as BMC schools in the vicinity do not have education beyond Std. VIII. Hence kids have to drop out of school after std. VIII or join Private schools for further studies. Looking at the grim economic scenario of students who cannot afford education, Private schools

are not really a choice. Hence, National Institute of Open School (NIOS) fulfils the need of completing children's school education at least up to Std. Xth. At Gyansaathi-NIOS centre, we cater to these children. This year total children who studied at the center were 116 and total children who registered with NIOS was 78.

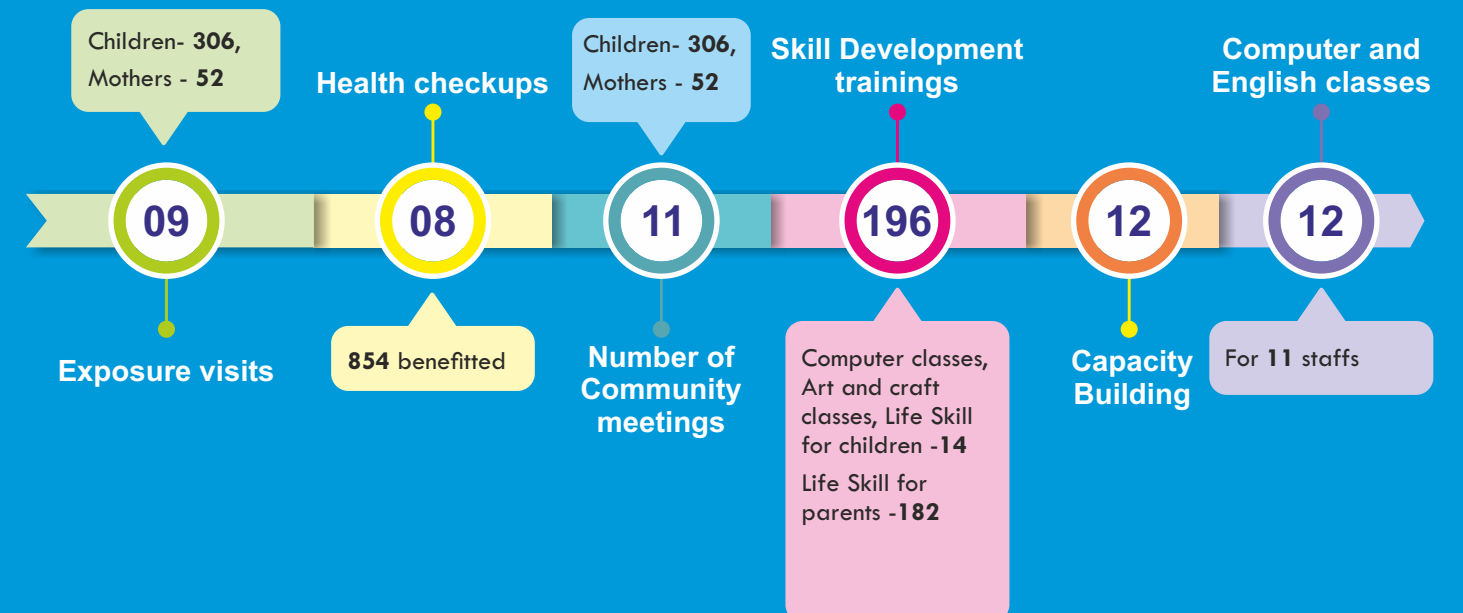

Case study

Rizwan, currently studying at Gyansaathi had admitted to substance addiction for years during his first counselling session.. He was then frequently counselled on the importance of education and ill effects of drug addiction. During counselling he became highly motivated to give up his addiction and slowly started improving. Now Rizwan is doing his best to get out of substance abuse . With his new de-addiction habits, he motivates his friends in the community to stop consuming drugs and bring awareness to its ill-effects.





Gyansaathi nonformal education centres

Gyansaathi-II is a project focusing on the holistic development of children from the rag picking community near the Govandi dumping ground. The project caters to a comprehensive approach to education, health, supplementary nutrition, psychosocial development, advocacy and community development.

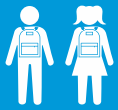

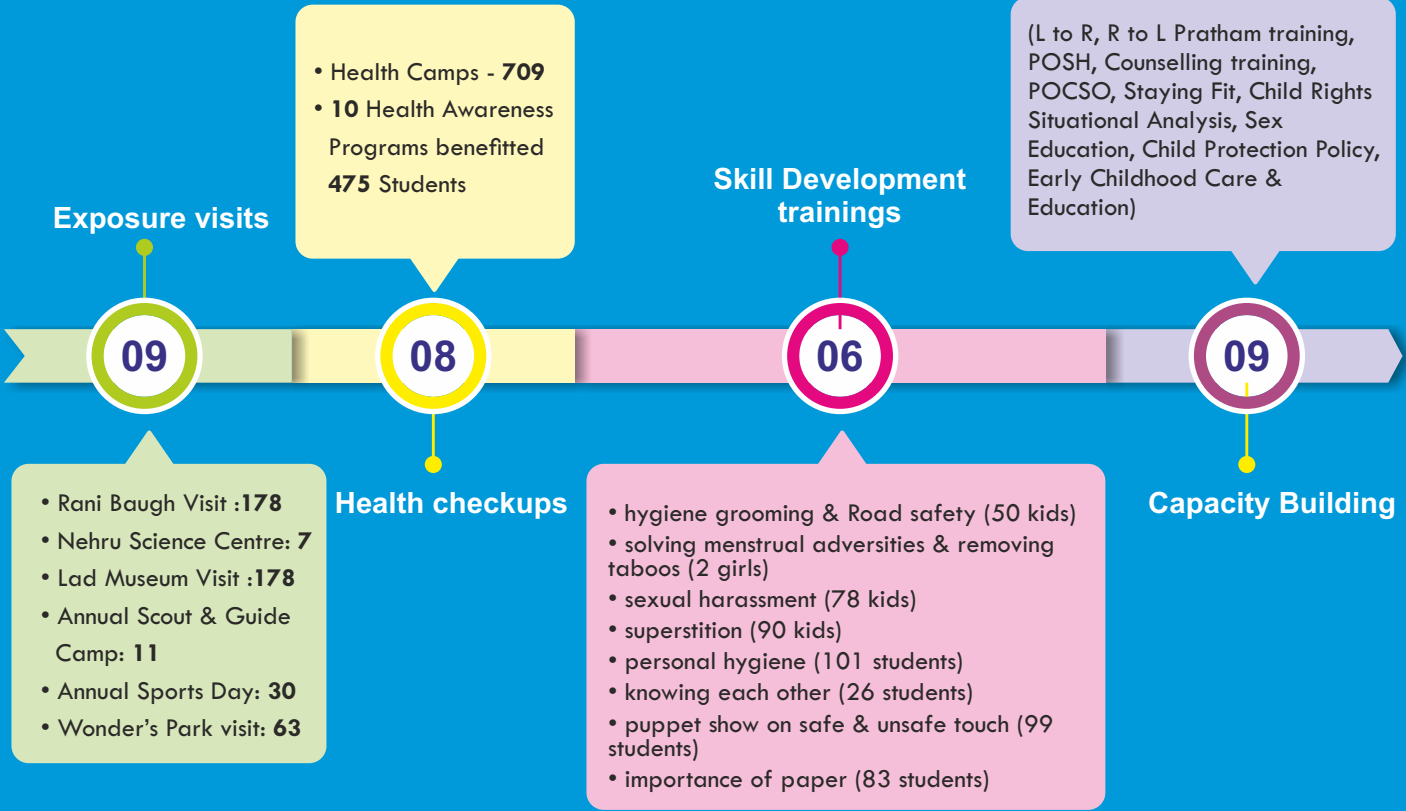

Case study

Rehana, age 10 years, is a school dropout. She had studied till Grade 3. Her family consists of her parents, 3 brothers and a sister. Rehana's parents are contesting a divorce over her mother having an adulterous affair, which has put her in mental trauma. Her elder sister found it difficult to manage the house and also take care of other siblings. She was counselled and presently is working as a part-time teacher. Rehana is now regular at Gyansaathi ever since both the sisters were counselled.





Gyansaathi Balwadi

Gyansaathi has started a new project, Balwadi (for children from 4 to 6 years of age) in April 2017. The teacher takes classes (use play way method), and involves children in various activities, cultural programme, telegame/ indoor games, various celebrations etc, and the supplementary nutrition

(Chyawanprash, Milk, Egg and seasonal fruits) are also provided to all the children.

Case study

In balwadi, a boy named Farhan akbar ali sayyed has been studying for the last 2 years. He had not been contacted for a long time in lockdown. Due to parents not having phones, it was becoming difficult for teachers to contact them. This is how mother talked to me after coming to the center.

I told Farhan's mother about the study that is going on right now, then his mother told me that she does not have a phone. Then she gave her neighbour's number and for some time she studied from this number. After depositing money for a few days, mother took the phone for the children's studies and started joining online classes.

After a few days, I talked to the mother about the child's school admission, then the mother also said that admission has to be done but in a good school. So Our salma teacher informed her about the RTE form and followed her till admission. The child has been admitted to Jafri school by RTE. After admission, the parents of the child were very happy and thanked the teachers of Gyansaathi.

Vocational Training is provided to the children above 16 years of age and their family members. Mostly the training is selected based on the field requirements in which the children have interest. These training help the Beneficiaries to earn their living. Total of 6 courses were conducted during the whole year. Total participants who attended different courses are as follows.

Case study

Zubeda is an ex-student of Gyansaathi. She took admission in vocational courses run by the centre for the community mothers and ex-students. She joined the Mehendi course and did both basic and advanced Mehendi courses where she learnt various patterns and designs (Barik design, Rajasthani, Pakistani, Bridal, Arabic, Dubai, Muglai etc.) for two months. After completion of the course she got National Skill Development Corporation approved certificate from Yuva Parivartan, an NGO. Last year during Diwali festival celebration organized by Deutsche Bank, Gyansaathi put a stall with its items. Zubeda got an opportunity to put a Mehendi stall in Deutsche Bank office where she demonstrated her art. She applied Mehendi to the customers and earned money. She also got an idea about the customers' demand, rate and got experience of doing small business. Now she gets orders from her community for marriage and festivals. She earns money which she uses for her studies and also supports her family. Currently she is studying in the college.

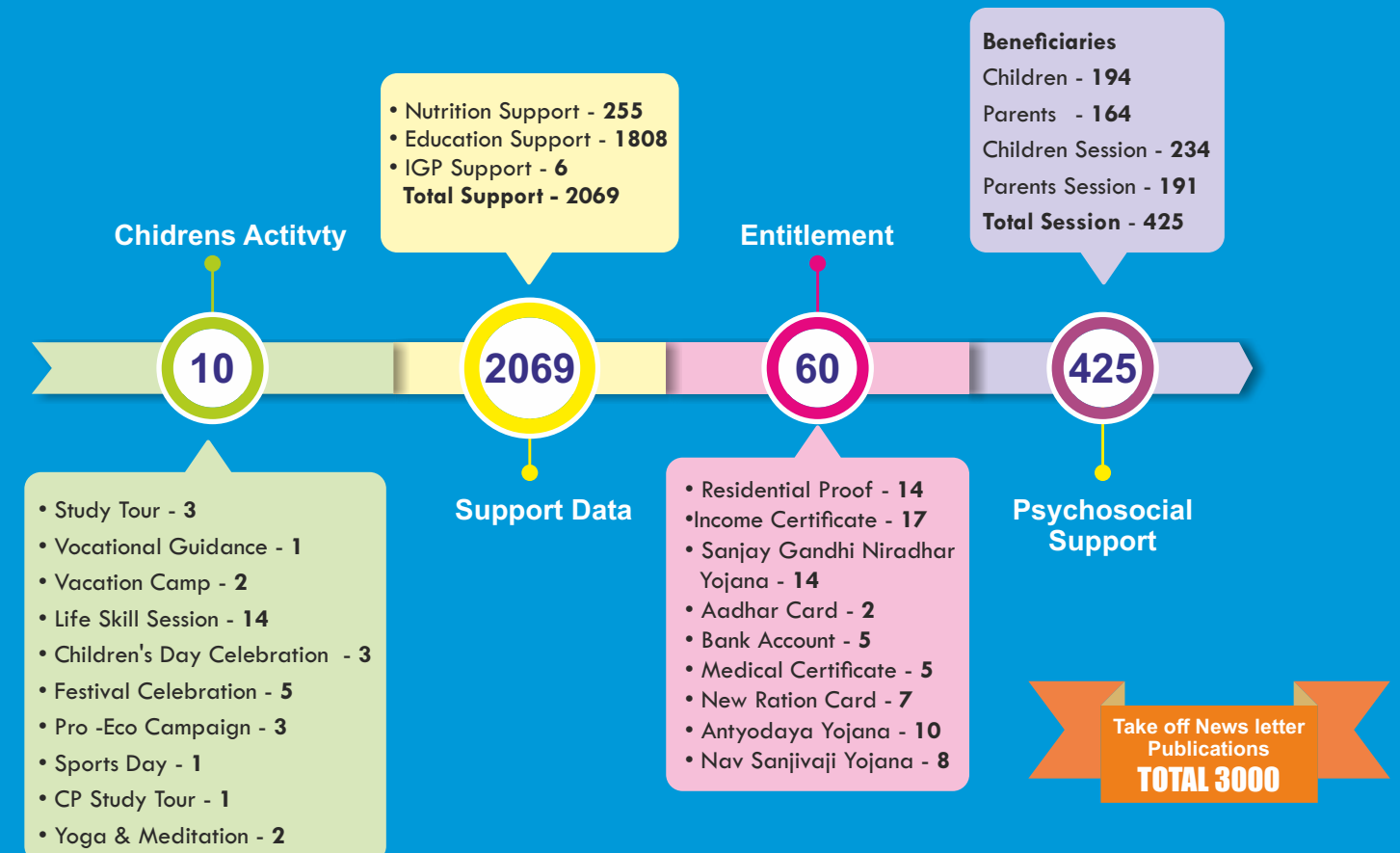

Case study

Fifteen year old Ankita lives with her mother and three younger siblings. Her father died from Tuberculosis.. Her mother too is infected by the same. Their two other relatives are also dependent on them for daily survival. Due to her mother's illness and father's death the family's socio-economic situation was very bad. There was no other support system due to which the children's education was also getting affected. Ankita and her siblings were not attending school and her mother too was depressed. Loss of father was negatively affecting Ankita and her siblings. Social workers at Savli motivated Ankita and her siblings to attend

school regularly by visiting their house. Through Savli's nutrition support, family had food to eat. With psychosocial intervention the mother was able to cope with her depression. Life Skill sessions helped them to lead a better life by maintaining discipline in their life and inculcating good hygiene practices. Now Ankita and her siblings go to school regularly and their behaviour has improved. Ankita has also become an active member of Project Savli.



Project JAN



JAN - Jubilee action Network

In collaboration with local Police and other like-minded people, the JAN (Jubilee Action Network) from Karunya Trust Nodal units render service to the destitutes. They pick up the destitutes, orphans from the street and rehabilitate them the care homes.



The phase of the sunset of life is the most trying time for those endowed with uncared health. It gets bad for those who are old frail and without any financial backup. In such circumstances if their families forsake them, the nightmarish unimaginable suffering of the elderly is unbearable. With failing health, no food and shelter, these elders are sometimes left on the roads or on pavements eating morsels thrown at them, surviving the vagaries of the weather and traffic, becoming ill and sometimes injured and without any hope or respite of future. In collaboration with Local Police and other likeminded people, the JAN volunteers from Karunya Trust Nodal units pick up the destitute from the streets and rehabilitate them to various care homes. JAN team could rehabilitate 129 people in the past 4 years.

Jeevan -Empowering Animation (EA)

Jeevan - Empowering Animation project is Implemented in 15 hamlets of Kalyan Block with 4040 population of 734 households. It is a process where people realized that they have inborn potentials for their own empowerment and have the capacity for collective action that leads them to the development of self and the community. The various examples, be it small or big

are leaving a legacy for people for more people-led initiatives. The goal of EA is to Empower tribal communities through Good Governance, Sustainable Agriculture, and Tribal Rights.

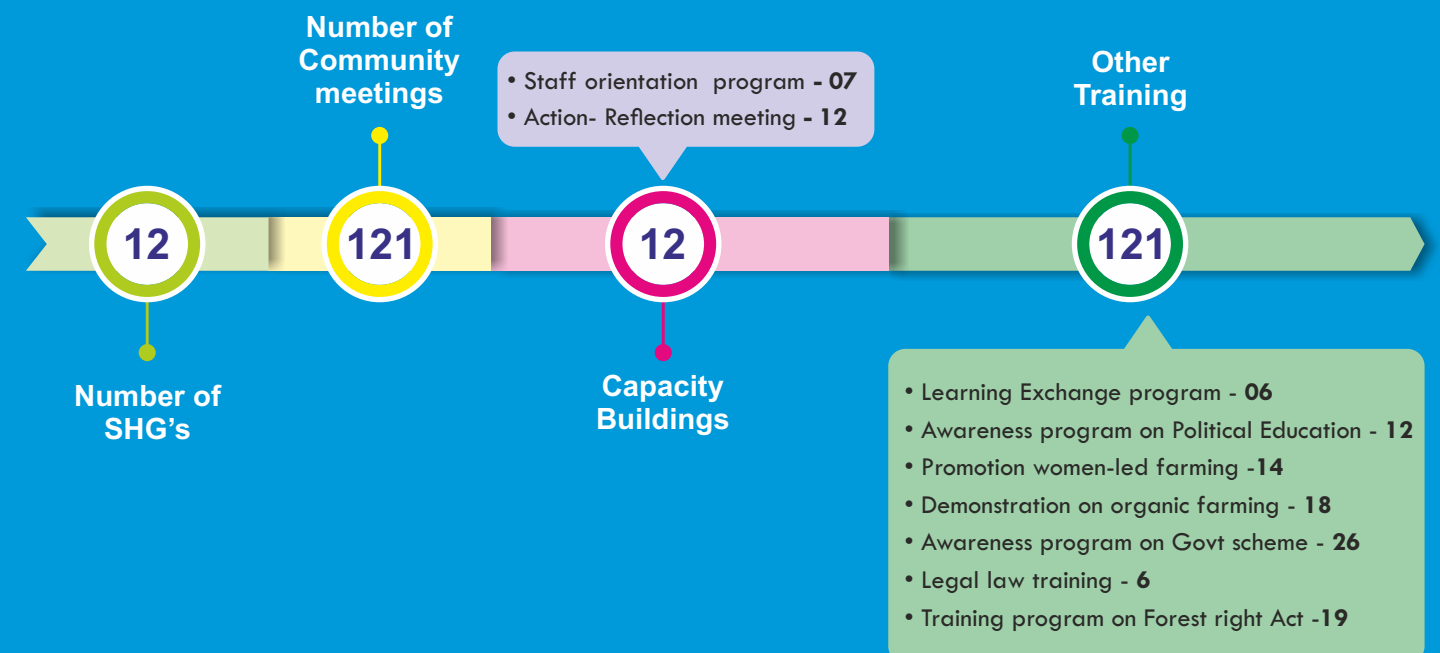

Nutrition is essential for human life. People have realized the value of good nutrition during COVID-19 pandemic. People of 5 hamlets of Kalyan Block started vegetable cultivation like nutrition garden in their hamlets. Dahivali is a small village of Kalyan Block of Thane District of Maharashtra where people depend on daily wages and farming. There are 55 families of two tribal communities which have good relations among them. They come together and work for village development. The major issue faced during COVID-19 pandemics was shortage of green leafy vegetable. People came together and worked on the plan of green vegetable garden. "During the lockdown we were unable to get fresh green vegetables as well as food. However, with the help of Karunya Trust we received Food grains kit from the government but did not have labour work. It was difficult to

manage the house. So we, 16 women, came together and shared our ideas with Karunya Trust. The Trust helped and supported us to bring our ideas into action," said Barkibai Fasale, one of the active community leaders.

"We decided to cultivate green vegetables in a group, so we listed different types of vegetables which is used in our daily meals like red leafy vegetable, cluster beans, brinjal, tomato, pumpkin, bottle gourd, amaranth leaves, fenugreek leaves, chilli, ladyfinger and spinach. The women were happy to work together. We took 0.2R land, cleaned, and sowed vegetable seeds in the field. Now we have green leafy vegetables all the time. We thank Karunya Trust for promoting and motivating vegetable garden for our benefit," said Pama Jadhav one of the active women in the hamlet.



Project Bharari

Project Bharari - SHA

Bharari-SHA project is based on Self Help Group Approach implemented in 16 hamlets of Ambarnath Block with 5825 population of 1284 households. It supports 1795 children in education and 53 Self Help Groups and 4 groups of Cluster Level Association, members of Katkari and Thakar community to empower

the women and avail the government facilities through the different trainings and awareness programs.

- Training on fundraising and management to 48 CLA members
- Training on compost fertilizer to SHG/CLA- 10 SHG/CLA members trained
- Account keeping and record maintenance- 15 SHG 45 leaders trained
- Functional literacy- 13 SHG and 120 members trained
- Training on Saving -loaning- 5 SHG 45 members trained
- communication, Strengthening and conflict management training- 6 SHG and 50 members
- Awareness of writing an application to government departments- 6 SHG and 22 members
- Awareness on the effect of superstitious beliefs -8 SHG and 72 members, 4 Street plays- 380 people are aware of various health topic
- Refresher training on SHA module orientation - to KNH India staff and Shri Lanka NC

During the pandemic, the family starved due to a lack of employment in the village. As a result, the family faced health problems. Kalpna said, "I was depressed but continued attending SHG meeting. Being a member of SHG, I had attended business skill training in the group. I desire to start a business but confused in starting goat-rearing or petty shop. My Self Help Group members guided me to set up a petty shop. To start business I have to invest the amount Rs 5000/- so I borrowed the amount Rs. 2000 from my relative and amount Rs. 2000/- loan from SHG. I had saving amount Rs.1000/- so from these amount I purchased the materials and started my own business from which I earn income Rs 250 to Rs 300 per day Now I am very happy, I thank Karunya Trust for motivating and helping me to start my business".

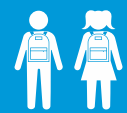

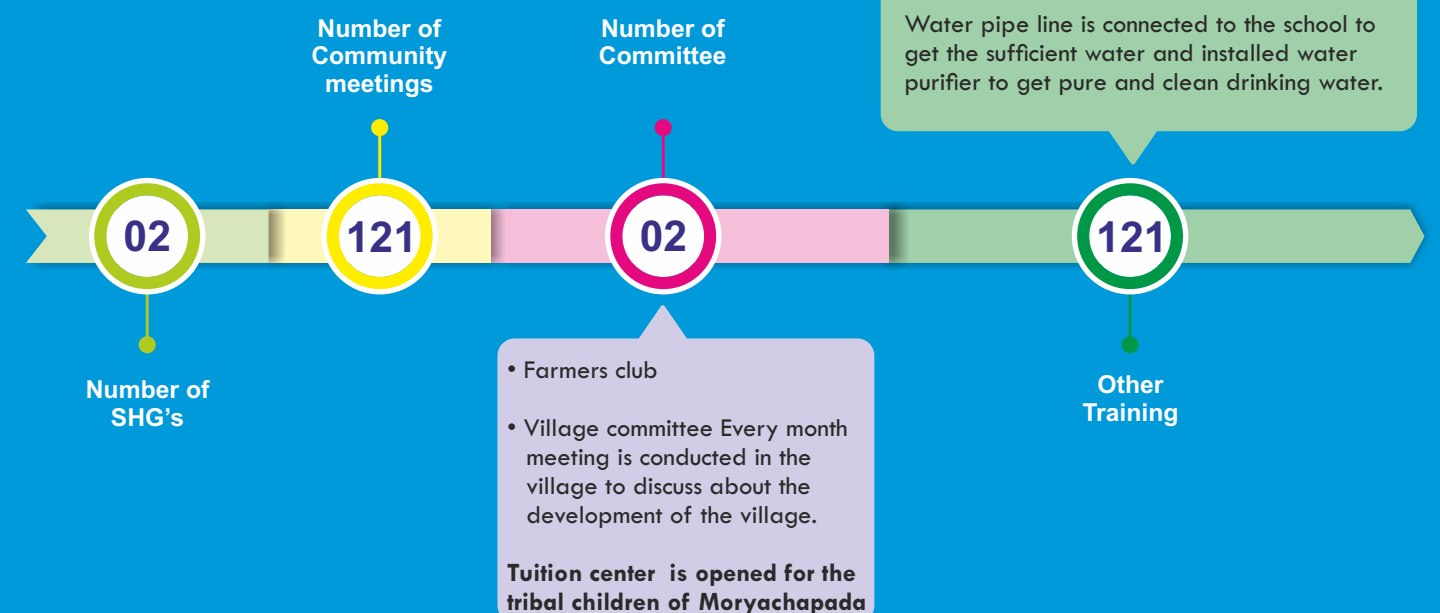

Case study

Shankar stays with his parents and family in a small village. Their occupation is only farming, which depends on the monsoon for irrigation. The Forest department had given him a small piece of land on which they cultivate rice and grow vegetables. The family collects firewood from the forest. Their daily life depends on forest and on rainy season. During summer, they face many challenges because the land is very dry and favourable for cultivation. Though their village is on the bank of 'Barvi River' and its water flows from the dam but is not able to connect to the field. Their financial status is weak and they are unable to afford a pipe line. Through Karunya Trust, Concern India Foundation visited their hamlet and sanctioned the water irrigation project which has brought much joy and happiness into the village. During farmers' meeting, they also

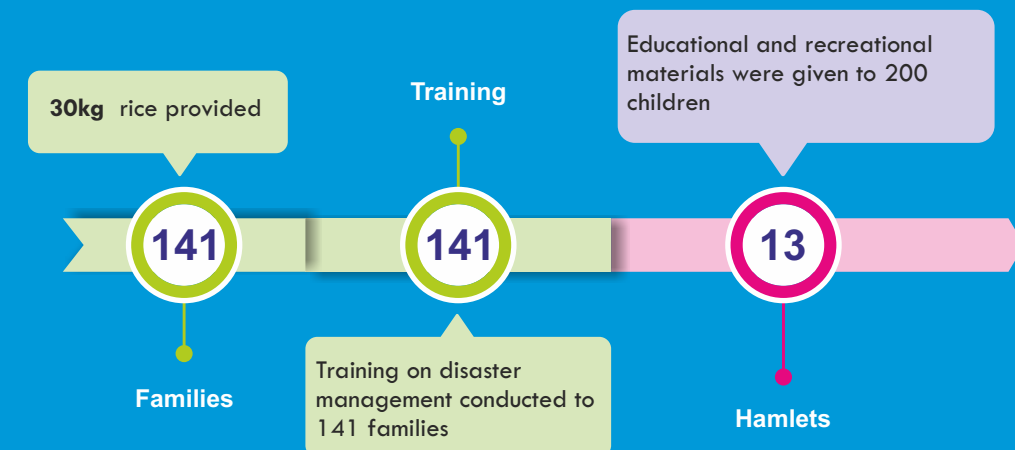
discussed on constructing the water tank and land needed for it. Shankar immediately agreed to donate his own land. This was a great opportunity to help his village farmers and they were at peace because the main issue of land was solved. The farmers worked hard to get the permission from the different government offices and contributed in labour work. Now everybody in the village is happy because water connection has been provided to their fields. The village has benefited as there is sufficient water to grow different kinds of vegetables. Their income will now increase, family members will be happy and children will have a bright future as people will send their children for higher education. Farmers now have sustainable farming and can cultivate organic vegetables for people.

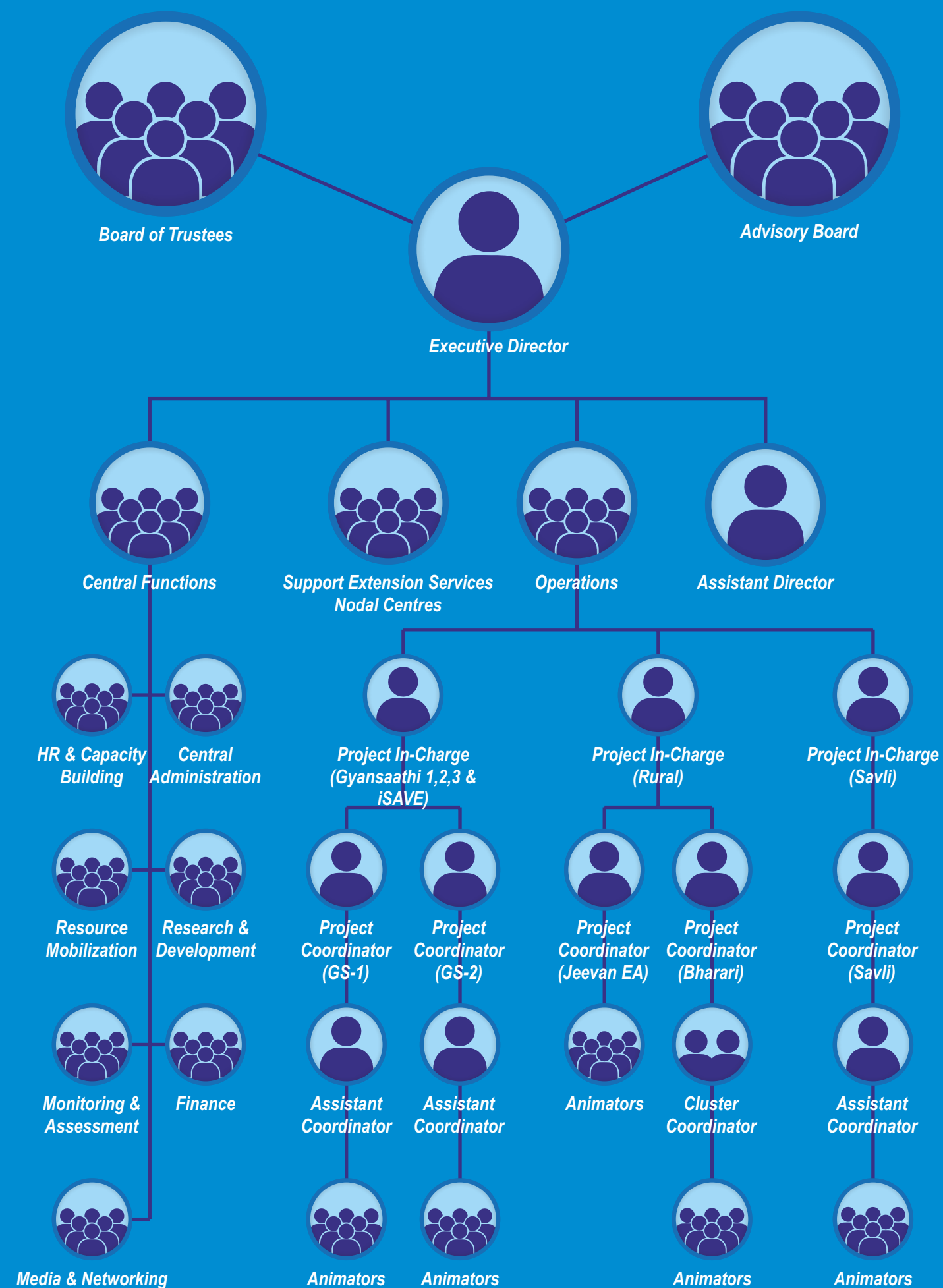

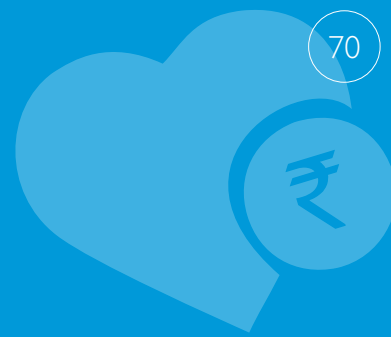
